#### **DUTIES:**

Serves as commander for the Public Affairs Detachment. Advises the chain of command on internal information, public information and community relations matters. Monitors operations of the command to assure consideration to public affairs implications. Supervises preparation of information of release on RIARNG matters through news releases, articles, and photographs. Supervises and provides guidance on operations of radio and television in conjunction with the State Public Affairs Officer. Advises on accuracy, propriety, timing and relative importance of information for release to the command. Recommends methods of communication information in various situations.

#### **REQUIREMENTS:**

1. Open to 1LT-CPT (O2/O3) qualified as a 46A or must be eligible and able to qualify as a 46A .
2. Officers must be eligible to become a member of the RIARNG.
3. Candidate must have a current dental exam and Periodic Health Assessment (PHA) within 12 months. Soldiers from out-of-state must be eligible to IST to the RIARNG.
4. Be in compliance with APFT and weight control program requirements.
