2. The enclosed MRD Handbook supersedes PPOM 19-011. This compilation of general information regarding retention of ARNG officers and warrant officers beyond MRD is updated.

3. The handbook serves as a quick reference guide to applicable statutes and policies. It does not replace or rescind any active provisions codified by current laws. This handbook is regarded as a "living" document and will change as statutory and regulatory guidelines are updated. ARNG-HRH will publish additional versions to support current policies and procedural guidelines.
